Subject: Draft Minutes of 12th 4-C Meeting and 2nd CPND Meeting

### I. Four Centre Meeting.

Action item 19 seems to be unnecessary as NNCSC made it clear that neither ENDF nor ENDL libraries will be indexed in CINDA by NNCSC in the foreseeable future.

### II. CPND Meeting

The last paragraph on the cover page of Memo CP-D/7 seems to conflict with Action item 25. We hope that the EXFOR and LEXFOR supplements will be written by NDS since we do not want to add this information to EXFOR and LEXFOR until an implementation schedule for NND is agreed upon.

### III. EXFOR

a) Conclusions about NND EXFOR System #2. We believe that EN-APRX is also misleading and prefer a new column heading EN-MIN-APX with an appropriate compiler comment.

b) Conclusions relevant to all EXFOR Systems #8. We do not recommend the use of pointers unless linked to a multiple isoquant in the BIB section because machine or visual checking will be more difficult. However, we can accept such constructions.

c) Conclusions relevant to all EXFOR Systems #11. We do not like to see informal proposals such as the paper presented by Japan at the CPND Meeting referred to as a CP Memo (CP-E/1). Memos should be constructed and distributed, and hence referenced only when established procedures have been followed.

d) Conclusions relevant to all EXFOR Systems #19. We prefer to terminate the sentence with "given by the author". The remainder is unnecessary. Also one should add that these quantities cannot presently be put in a single subentry for NND EXFOR.

e) Conclusions relevant to all EXFOR Systems #26. We prefer that the keyword STATUS be used with pointers as an extension of current practice.

f) Add to conclusions relevant to all EXFOR Systems that only a single representation of a variable is allowed within a subentry. That is column heading (EN and WVLN) or (ANG-CM and ANG) cannot appear in the same subentry unless they have different pointers.

Also we believe that there has been sufficient time to ascertain whether the Indian CPND center tentatively designated as center K is in the network or not. The final minutes should list them as a full member or they should be removed from the network list.
