Subject: Dictionary update

We are sending out an interim dictionary update (Rev. 1 of TRANS 9059) containing the following alterations:

- The changes proposed in Memo CP-D/185 of 10 October 1988 for REACTION combinations. No objections to this have been received, on the other hand the new formalism was used already on TRANS 1233. (New BIB keyword RESULT with new dictionary 37, new headings EN-NM, EN-DN etc. in dictionary 24).

Final approval will be requested at the forthcoming NRDC-Meeting.

- A new STATUS code RIDER (used in TRANS 1233) was introduced although this was not proposed in a memo.
- Conference code 89TASHKE for the 39th Conf. on Nucl. Spectroscopy and Nuclear Structure, Tashkent, April 1989.
- The erroneous lab code 3CSRPFU (code and expansion are both misleading) is obsoleted and replaced by 3CSRUB. The only Exfor entry where PFU had been used will be retransmitted on our next TRANS tape so that PFU can be deleted in the next update.
